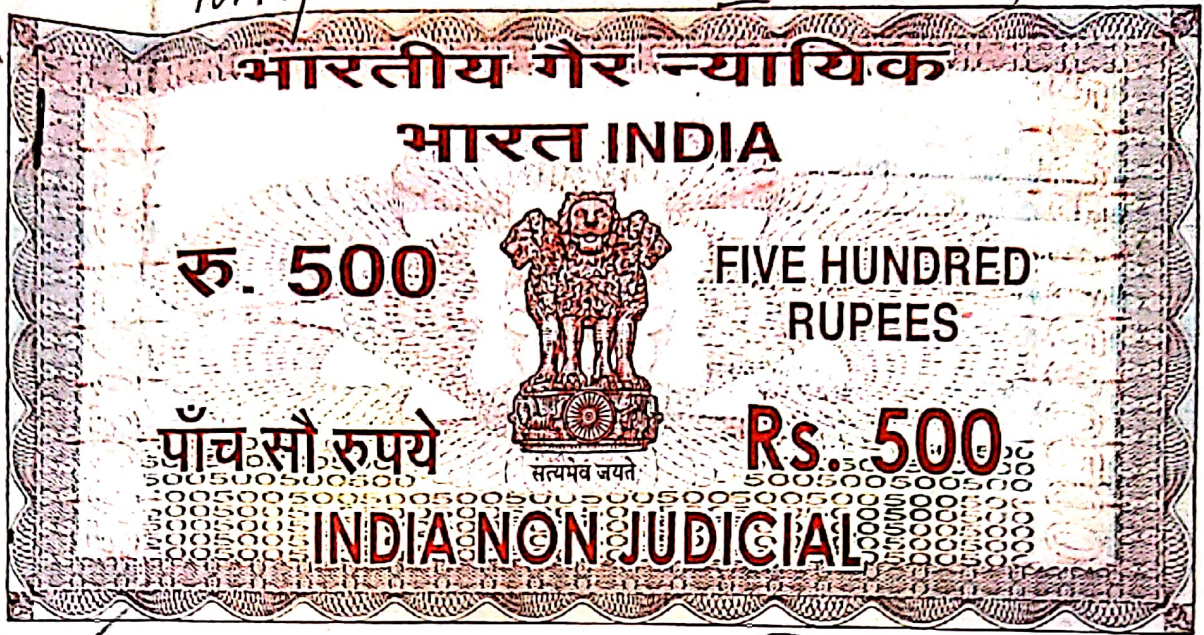

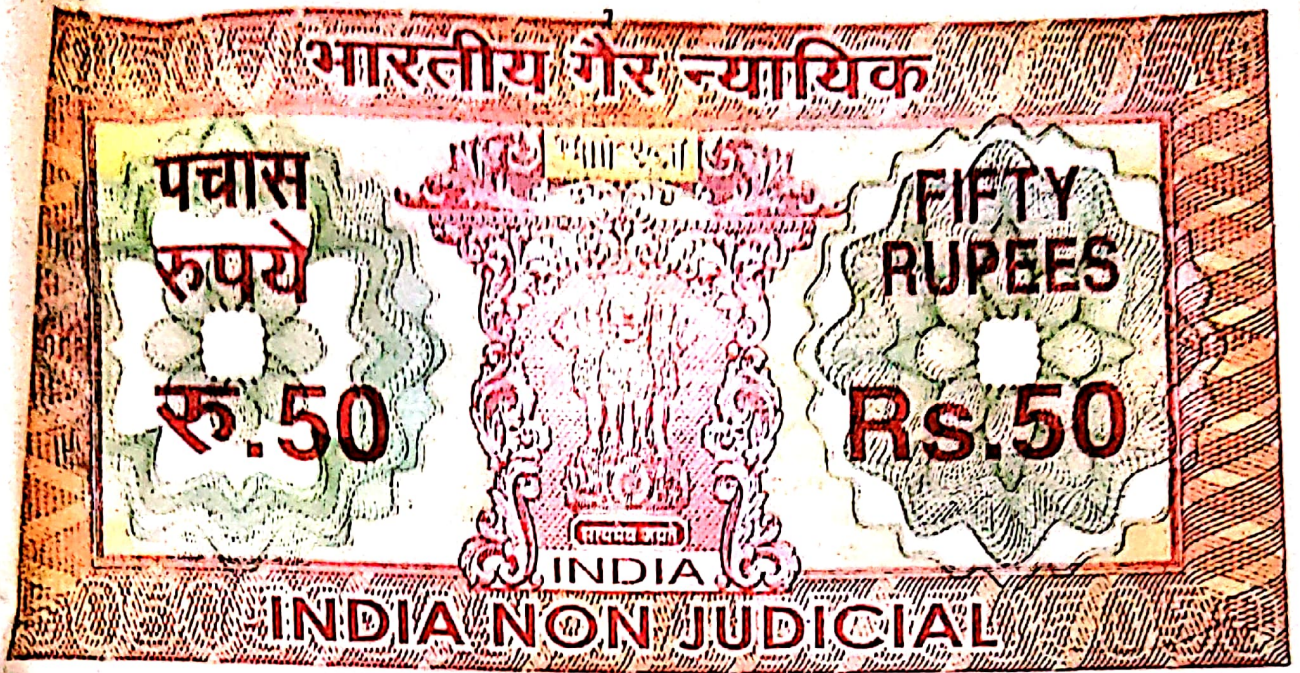



2. THE REGISTERED OFFICE AT VILL- NAYANGAON P.O.-PAROI, P.S. MOHANPORE, DIST: WEST MEDNAPORE, PIN-721436, UNTIL SUCH TIME AS THE TRUSTEE DECIDE OTHERWISE.

3. AT PRESENT THE TRUST HAS NO IMMOVABLE AND LANDED PROPERTY IN ITS OWN NAME AND NO IMMOVABLE AND LANDED PROPERTY IS BEING SETTLER IN FAVOUR OF THIS TRUST BY THIS DOCUMENTS.


4. The main objects of the Trust are to alleviate property in a sustainable and sustained manner, of ever larger numbers of poor and old people, particularly poor and women and child.


i. The Trust aims to facilitate entrepreneurial activities by provision of help to poor rural people. It will also work to help, create financial resources to serve the poor women and their families, to tide over the many emergencies they face regularly, such as ill health etc. The Trust will work to facilitate over all social development of poor women and child, their families and there communities to the degree possible, with minimum possible additional financial input. The Trust will work to help establish institution to do all of the above in a sustain and sustainable manner for the long run.

ii. The Trust may also establish any kinds of educational institutions, and promote any kind of research, health promotion and any other object of general public utility.


iii. The other aims and objects shall be

- a). To promote amongst the poor section of the population.
- b). To promote and administer schemes for persons belonging to poorer and disadvantaged section of the population.
- c). To promote and administer schemes for improving health, nutrition, sanitation, literacy and housing amongst the poor section of the population.
- d). To provide support services and encouragement to poverty alleviation programmers.
- e). To provide finance for social welfare programme, community development projects, project for providing housing to the poorer and old age section of the community.
- f). To organize training programme and to provide educational facilities to the poorer sections of the community.



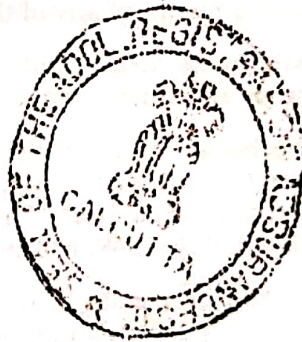

- m). To conduct, perform or carry on any of the above activities or any activity in pursuance of the above object either jointly or in collaboration with any scheme for the furtherance or attainment of any of the above objects.
- n). To design, formulate, execute or carry out any scheme for the furtherance or attainment of any of the above objects.
- o). To do all such acts, deeds and things as are necessary or incidental to the furtherance or attainment of the above objects.
- p). To fulfill the basic objects of the Trust, the Trustee will be at liberty to collect/ donation/ grant/ loans/ distribute any funds as per provision of the Negotiable Instrument Act, 1881, The Reserve Bank of India Act, 1934, The Banking Regulation Act, 1949, or the rules or regulations made there under.
- q). The income and properties of the Trust whatsoever derived or obtained shall be applied solely towards the promotion of the objects of the Trust and no portion thereof shall be paid to or divided amongst any of the Trustee or any person by way of profit.
- r). To carry out any other activities and/ or object which is covered with in the definition of charitable purpose as per the provision of Income Tax Act 1961 and/ or any amendments there on.
- s). The objects of the Trust shall be for the benefit of all the sections of society irrespective of their caste, creed and religion etc.
- t). To object of the Trust will be pursued only within the territories of India.

w) The Trust will never Acts which are illegal and unlawful in nature and also which will oppose to the public policy and contrary to the law of Country,

v) The Trust will never Acts like Micro-finance and money lending in nature and shall not take or obtain any donation in like that from aboard/foreigner public or financial institution or bank.

5. NATURE OF THE TRUST:

The Trust shall be a secular and charitable Trust having no commercial or profit motive. 9. VACANCIES :

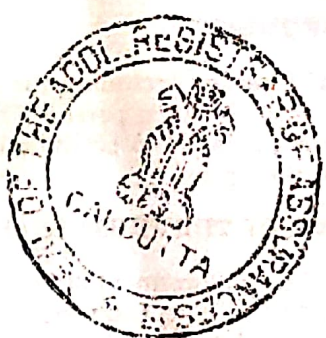




10. DISPUTES;

If a dispute arises between the trustees about the validity or property of anything done by the charity trustees under this deed, and the dispute cannot be resolved by agreement, the trustees party to the dispute must first try in good faith to settle the dispute by mediation before resorting to litigation.

11. STATUTORY POWERS:

Nothing to their statutory powers, the trustees may delegate any of their powers of functions to committee of two or more trustees. A committee must act in accordance with any directions given by the trustees. It must report its decisions and activities fully and behalf of the charity except in accordance with a budget previously by the trustees.

12. DUTY OF CARE AND EXTENT OF LIABILITY.

i. when exercising any power (where given to them by these deed, or by statute, or by any rule of law) in administering or managing the charity, each of the trustees must use the level of care and skill that is reasonable in the circumstance, taking into account any special knowledge or experience that he or she claims to have ('the duty of care').

ii. No trustee, and no one exercising powers or responsibilities that have been delegated by the trustees, shall be liable for any act or failure to act unless, in acting or in failing to act, he or she failed to discharge the duty of care.

13. ELIGIBILITY FOR TRUSTEESHIP :

i. No one shall be appointed as a trustee.

a. If he or she is under the age of 18 years, or

b. If he or she would at one be disqualified from office under the provisions of clause 21 of this deed.

ii. No one she be would entitled to act a trustee whether on appointment or on any re-appointment as trustee until he or she expressly acknowledged, in whatever way the trustees decided, his or her acceptance of the office of trustee of the charity.

14. TERMINATION OF TRUSTEESHIP :

A trustee shall cease to hold office he or she.



16. REPAIR AND INSURANCE :


The trustees must keep in repair and insure to their full value against fire and other usual risks all the building of the charity (except those building that are required to be kept in repair and insured by a tenant. 17. EXPENSES :

The trustees may use the charity's funds to meet any necessary and reasonable expenses which they incur in the course of carrying out their responsibilities as trustees of the Charity.

18. AMENDMENTS :

 - b. No amendment may be made that would have the effect of making the charity cease to be a charity at law.
 - c. No amendment may be made to alter the objects if the change would undermine or work against the previous object of the charity.
2. Any amendment of this deed must be made by deed following a decision of the trustees it should be fixed at a special meeting.



3. The trustees must send to the Registrar of charity a copy of the deed effecting any amendment made under this clause within three months of it being made.

19. The Trust shall have a common seal, logo, emblem of such 'make' and 'design' as recommended by the Board of Trustees.

20. FORMATION OF BOARD OF TRUSTEES:

The Trustee whose names and addresses have been registered hereinbefore are being the first trustee and are forming the 'BOARD OF TRUSTEE' for the Trust. The number of the Trustee shall not be more than 10 (ten) and less than 2 (two).

21. POWER AND DUTIES OF THE TRUSTEES AND BOARD OF TRUSTEES;

The Trustee shall names the properties of the Trust called here as "BIJAY KRISHNA AND SANTABALA MEMORIAL TRUST" and shall not allow the said allow the said properties to be used by any person / persons whose activities are in the opinion of the Trustee not in conformity with the aims and objects of the Trust.

i). The Trustee shall hold the office for the whole life unless occurrence of any one of the events specified in the Clause No. 9 of this deed.

ii). The Trustee will be entitle to remuneration and designation on rendering specific services or on appointment for specific assignments based on their professional abilities as decided by the Board of Trustees. This remuneration or salary shall not be treated as an entitlement arising out of their position as a Trustee but as compensation for their professional service equal to any other professional as per The remuneration amount is to be decided by the Board of Trustee through a resolution taken to the effect.

iii). In case of vacancy amongst the Trustee, the remaining Trustee shall by majority of votes appoint a new Trustee. Any casual vacancy may occur amongst the Trustee shall be filled in with in 6 months from the date of vacancy and in the manner said herein before.

iv). The continuing Trustee may act notwithstanding any vacancy in the Board of Trustee, provided, however, that if the number of the Trustee shall fall below the minimum fixed in clause herein before. The Trustee shall not except for the purpose of any vacancy, act so long as the number is below the said minimum.

v). The Board of Trustee shall cause true and fair accounts to be kept of all money receive and spent and all matters in respect thereof in course of management of Trust properties or in relation to carrying out the objects

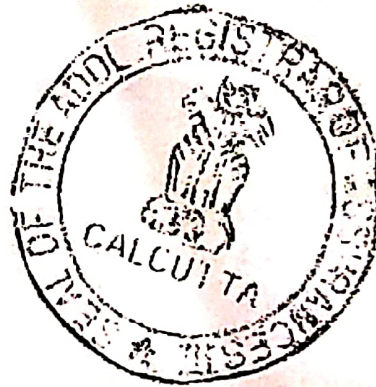



and purpose of the Trust as well as assets, credits and effects of the Trust properties and get such accounts audited annually by qualified chartered accountant duly appointed by the Board of Trustees. For this purpose, by the Board of Trustees shall follow the accounting year of the Trust from 1st April of each year to 31st March of the next year.

vi). The Board of Trustees shall from time to time after meeting the expenses of an incidental to the management of the Trust properties and of the Trust decide the particular object or objects for which the income or portions for the trust properties for the time being available shall be applied.

vii). The Board of Trustees in the interest of the Trust may invest the asset of the Trust fund either in purchase of mortgage of immovable properties or in investment of such security authorized by the Indian Trust Act, 1882 or in deposit with any schedule or nationalized bank subject to compliance with the provision of the Income Tax Act, 1951 and / or any other Governing the charitable Trust for the time being in force.

viii). The Board of Trustees in the interest of the Trust shall be at liberty to sell of such portion or portions of the movable and/ or immovable properties, forming part of the Trust fund either by public or private contract as such price and on such terms and conditions relating to title or otherwise in all respect as they may in their discretion think fit and to rescind or vary a contract for the sale thereof and to resell the same and for the purpose to execute all necessary conveyances, transfer or other assurance and to pass valid and effectual receipts and discharge for all money received by them. The Trustee shall have the full power to construct, maintain, improve, develop or alter any building, houses, or other works necessary or convenient for the Trust.

ix). The Trustee shall pay all charge and outgoing payable in respect of any immovable property for the time being forming the Trust fund and may carry out repairs required to be done to the same and keep same insured against loss and damage by fire and may incur all other costs and charge and expense of an incidental to the administration and management of the trust fund and the property of the time being belonging to the Trust as they may in their discretion think fit.

x). The Trustee may in the interest of the Trust demise in immovable properties for the time being and from time to time let out the properties belonging to the Trust either from year to year or for any larger number of years or on monthly tenancies at such rent and subject to such covenants and terms as they think fit and proper.

The Trustees may also take over the management of any similar charitable institution which is registered under section 12AA of the Income Tax Act, 1961, on such terms and they think fit and manage such institution for the good of the public.

xii). The Trustee may in the interest of the Trust, raise or borrow moneys require for the purpose of the Trust with or without any security on a mortgage or pledge of the Trust properties or may part thereof and at such rate of interest and on such terms as they may in their discretion think fit.

xiii). The Trustee shall have full power to compromise or compound all action suits and other proceedings and all difference and disputes touching the Trust and / or the Trust property and refer such dispute or differences to arbitration and to adjust and settled all accounts relating to Trust estate and / or the Trust properties and to do all other acts and thinks as fully and effectively as if they were absolutely entitle to the Trust estate and Trust properties with beings liable or answerable for any loss occasioned thereby.

xiv). The receipt of the Trustees for any money, stocks, funds, shares, security or investments paid, delivered or transferred to them in execution of the Trust and power thereof shall effectually release and discharged the person or persons delivering of transferring the same there from and from seeing or from being bound to see to the application or being answerable to the loss or misapplication thereof.

xv).
